20.09.2022 ORDER

Real Estate Regulatory Authority, Bihar issued a suo motu show-cause notice on 03.05.2018 to the Directors of the respondent company for contravention of section 3 of the Real Estate (Regulation & Development) Act 2016 by advertising the project **Vastu Vihar Chapra-1** through the brochures on their website without registering the project with the RERA, Bihar. The promoters were directed to show cause as to why proceedings under 59 of the Real Estate (Regulation & Development) Act 2016 may not be initiated against them. It was brought to the notice of the Authority that the respondents have been advertising and taking advances against the bookings made in the project.

The respondent company in its reply dated 19.05.2018 had stated that the said project was outside the planning area and hence, they have not taken any steps for registration and undertake that they will not make any construction without approval. They have also submitted that once the area of the project is notified, they will apply for registration.

The Authority takes note that under the first proviso of Section 3 of the Act, all the ongoing real estate projects were required to register by 31st July, 2017 with the Real Estate Regulatory Authority, Bihar except in projects where area of the land proposed to be developed does not exceed five hundred square meters or number of apartments proposed to be developed does not exceed eight inclusive of all phases. Further, section 3 of the Act provides that no promoter can advertise, market, book, sell or offer for sale or invite persons to purchase in any manner any plot, apartment or building as the case may be, in any real estate projector part of it, in any planning area within a State, without registering the real estate project with the Real Estate Regulatory Authority (RERA) established under this Act. Promoter of ongoing real estate projects in which all buildings as per sanctioned plan, have not received Completion Certificate, shall also be required to be registered for such phase of the project which consists of buildings not having occupation or Completion Certificate.

On hearing dated 21.06.2022, the Bench observes that the only issue to be decided in the present case is whether they have violated Section- 3 of the Act.

The respondent in their reply have stated that the project was launched before the commencement of the Act and all bookings were completed before the commencement of the Act. In the application for registration, the respondent company has mentioned the project start date as 27.10.2011 and end date as 30.04.2021.

It has been further stated that the project was registered on 25.03.2019 but, in the registration certificate, Khata and Khesra has wrongly been mentioned. It has further been submitted that they filed rectification petition 01.04.2019 and 04.04.2019 which was not acted upon. However, when the respondent company filed extension petition, on 25.06.2021 and the project of the respondent company was withdrawn for getting the map of the said project approved afresh.

In the present matter even though the respondent company is claiming that they have not booked any plot or made any advertisement of the project after commencement of the Act but, they have admitted the fact that the project was ongoing and after issuance of suo-motu notice, they have applied for registration of the project **Vastu Vihar Chapra-1**.

The term Advertisement has been defined in the section 2 (b) of the Act as follows:

"Advertisement means any document described or issued as advertisement through any medium and includes any notice, circular or other documents or publicity in any form, informing persons about a real estate project, or offering for sale of a plot, building or apartment or inviting persons to purchase in any manner such plot, building or apartment or to make advances or deposits for such purposes."

Thus, it is established that the respondent company has advertised their project without registering the project with the Authority and thereby violated the provisions of Section 3 of the Real Estate (Regulation & Development) Act, 2016.

The Authority observes that the respondent company have contravened the provisions of section 3 of the Real Estate (Regulation and Development) Act, 2016 by advertising their project "Vastu Vihar Chapra-1". If any promoter fails to register the project as per the Act, they are liable to pay a penalty which may extend up to ten per cent of the estimated cost of the real estate project.

The Authority takes note that after issuance of suo motu notice, the promoter had applied for registration of the project **Vastu Vihar Chapra-1** by paying an amount of Rs. 5,23,839.65/- as registration charge along with late fee. In their application form they have mentioned Rs. 3,09,05,000/- as estimated cost of development and Rs. 7,34,372/- as estimated cost of land.

A late fee of Rs 5 lakhs has already been taken form the promoter at the time of registration, which works out to be more than 1.5% of the project cost. The Authority decides not to impose any further penalty as the promoter had applied for registration after the issue of notice. The amount taken as late fee may be deposited under the appropriate head.

With these observations and directions the matter is disposed of.
